Bids in sealed envelope clearly marked **“Procurement of Hearing Aids”** and reference number **MSS/OAB 02/2018-19** should be addressed to the **Permanent Secretary, Ministry of Social Security, National Solidarity, and Environment and Sustainable Development (Social Security and National Solidarity Division)** and deposited in the Bid Box situated at **12<sup>th</sup> Floor, R. Seeneevassen Building, Corner Jules Koenig & Maillard Streets, Port Louis** on or before **Wednesday 22 August 2018 up to 13 30 hours** (local time) at latest.

Bids submitted by mail should be sent to the same address as above with mention **“12<sup>th</sup> Floor Registry”** so as to reach by same date and time. Electronic bidding shall not be permitted. Late bids will be rejected.

Bids will be opened in the Conference Room of the **Ministry of Social Security, National Solidarity, and Environment and Sustainable Development (Social Security and National Solidarity Division)** on the same day at **13 45 hours** in the presence of bidders/bidders' representatives who choose to attend.

The **Ministry of Social Security, National Solidarity, and Environment and Sustainable Development (Social Security Division)** reserves the right to :

- (a) accept or reject any bid;
- (b) split the contract; and
- (c) annul the bidding process and reject all bids at any time prior to contract award, without incurring any liability towards the bidder.
