Bids submitted by mail should be sent to the same address as above with mention “**12th Floor Registry**” so as to reach by same date and time. Electronic bidding shall not be permitted. Late bids will be rejected.

Bids will be opened in the Conference Room of the **Ministry of Social Security, National Solidarity, and Environment and Sustainable Development (Social Security Division)** on the same day at **13 45 hours** in the presence of bidders/bidders’ representatives who choose to attend.

- (a) accept or reject any bid; and
- (b) annul the bidding process and reject all bids at any time prior to contract award, without incurring any liability towards the bidder.
