Procurement of Goods, Works and Services shall be conducted through Bidding Procedures according to the Public Procurement Act 2006.

Applications shall be received not later than **Wednesday 26 October 2016** up to 15 00 hours (local time) at latest. Late submissions will not be considered.
5. Price shall not be submitted at this stage.
6. Suppliers who submitted their application in the past are kindly requested to submit fresh application.
