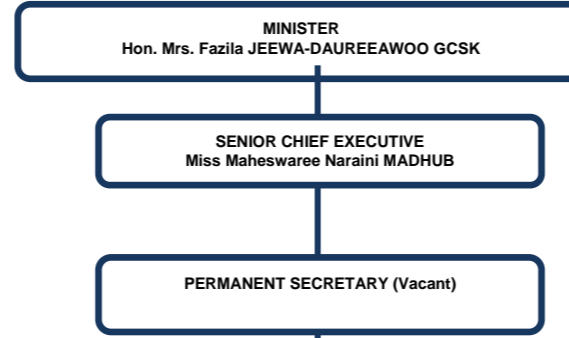


ORGANISATION CHART as at 11 September 2023
