The Ministry of Social Integration, Social Security and National Solidarity has undergone a reinforcement of a workplace culture that inspires collaboration, empowers individuals, and cultivates the importance of diversity, equity and inclusion.

There are numerous challenges that we are coping with, thanks to the collaboration of staff as well as external stakeholders. There are some processes that need to be reengineered. My focus is on teamwork and to achieve our objectives, a communication strategy is in place so that the Ministry delivers as one institution.

# DEPARTMENT/UNIT

# **KEY FUNCTIONS**

# **Social Security**

Provision of universal Basic and Contributory Pensions, National Savings Fund, Portable Retirement Gratuity Fund, Transition Unemployment Benefit, social assistance including financial grant for purchase of hearing aids, wheelchairs, spectacles and dentures, to the most vulnerable groups. (Applications may be registered at the local

# Welfare and Elderly Persons' Protection Unit

Ensures protection of the elderly, organises public awareness campaign on rights of elderly persons and exercises general supervision and control over Residential Care Homes.

Organises leisure and recreational activities for senior citizens at Elderly Day Care Centres (List at Annex II).

#### **Medical Unit**

Provision of free domiciliary medical visits to bedridden persons or severely disabled persons aged 0 - 89 yrs as well as all persons aged 90 yrs and above.

Provision of anti-influenza vaccination for the elderly and persons with severe disabilities including children.

Provision of medical and para-medical care to inmates of Charitable Institutions.

# **Disability Empowerment Unit**

Acts as the focal point for all disability issues and works for the protection and welfare of persons with disabilities. It also provides an array of direct services to persons with disabilities such as counselling, guidance, amongst others. The Unit also coordinates matters relating to the UN Convention on the Rights of Persons with Disabilities which Mauritius has signed in 2007 and ratified in 2010.

#### **Recreation Centres**

Provision of residential recreational activities for the leisure and entertainment of the senior citizens and persons with disabilities during their stay at Recreation Centres (List at Annex III).

## **BENEFITS SECTION**

# **National Pensions Scheme (NPS)**

The National Pensions Scheme provides for payment of earning-related Contributory Pensions under the National Pensions Act 1976 to those who have contributed to the National Pensions Fund up to August 2020 and also for the payment of universal Non-Contributory Benefits.

As from September 2020, contributions are no longer paid to the National Pensions Fund but as social contributions under the Social Contribution and Social Benefits Act which makes provision for the payment of Retirement Benefit as from the age of 65, Industrial Injury Benefit and Disability Allowance.

#### **Overview of the National Pensions Scheme**




Figure 1: Overview of the National Pensions Scheme

### **National Savings Fund (NSF)**

The National Savings Fund was set up in 1995, to provide for the payment of a lump sum at retirement age or earlier as described below, to all employees including those from the public sector.

A lump sum comprising contributions and accrued interests are paid in the following circumstances to:-

- (i) every employee at retirement age;
- (ii) every employee who becomes redundant at the age of 45 or more;
- (iii) every employee who retires on medical ground irrespective of age;
- (iv) every employee opting for early retirement as per provision contained in appropriate legislation to that effect;
- (v) widow/widower;
- (vi) heirs (children and/or legal representatives) where an employee dies before reaching retirement age; and
- (vii) non-citizen whose contract of work has been terminated and is returning to his/her country.

Every employer (public, parastatal body or private) has to effect a monthly contribution of 2.5% of the basic wage or salary (up to a ceiling) of every employee, aged between 18 and retirement age. This also includes household workers. Since February 2009, employees of the private sector also contribute 1% of their basic wage to the NSF.

## Transition Unemployment Benefit (TUB)

The Transition Unemployment Benefit is payable to workers of the private sector whose contract of employment has been terminated, for a minimum period of one month and a maximum period of twelve months.

Under TUB, the laid off worker is entitled to 90% of his insurable salary for the first 3 months, 60% for the next 3 months and 30% for the last 6 months, subject to a minimum of Rs 3,000 per month. TUB is payable as from the month of redundancy until the person becomes gainfully employed or sets up a small business.

TUB is financed by 1% of employees' (NSF) contributions; the Workfare Programme Fund and Government Grant.

## Portable Retirement Gratuity Fund (PRGF)

#### 1. Brief on Portable Retirement Gratuity Fund

The Portable Retirement Gratuity Fund (PRGF) has been established following the proclamation of the Worker's Rights Act 2019.

The purpose of the PRGF is to provide for the payment of a gratuity to a worker on retirement or to the legal heirs on the worker's death irrespective of the number of employers for whom he may have worked for. It also includes a self-employed who has contributed to the PRGF.

The employer pays 4.5% of the worker's monthly remuneration.

## 2. Objective of Portable Retirement Gratuity Fund

The objective of the Portable Retirement Gratuity Fund shall be to provide for the payment of a gratuity: - to a worker on his retirement;

to the legal heirs of a worker, on the death of the worker;

to a self-employed who has contributed to the PRGF, on his retirement; or

(d) to the legal heirs of a self-employed who has contributed to the PRGF on the death of the self-employed.

# 3. Eligibility to join Portable Retirement Gratuity Fund

(1) Any worker or self-employed, other than -

a job contractor;

a public officer or a local government officer; or

a worker whose retirement benefits are payable -

under the Statutory Bodies Pensions Funds Act; or

in accordance with a private Pension Scheme;

A migrant worker or a non-citizen; and

(e) A worker drawing a monthly basic wage or salary of more than 200,000 rupees shall be eligible to join the Portable Retirement Gratuity Fund.

#### 4. Application for PRGF Lump Sum

Application for PRGF is made to the Social Security Office nearest to the residence of the applicant.

# **Industrial Injury Benefits**

Following the proclamation of the Social Contribution and Social Benefits Act 2021, a multitude of Industrial Injury benefits are paid to an employee who suffers from personal injury which is caused by an accident arising out of and during the course of his or her employment or a disease due to the nature of his or her employment.

#### **SOCIAL AID**

Social Aid, commonly referred to as Social Assistance, is provided to assist people who are temporarily and/or permanently incapable of earning adequately their livelihood and do not have sufficient means to support themselves and their dependents. Social Aid is given in the following circumstances: -

- (i) Physical or mental disability;
- (ii) Abandonment by spouse;
- (iii) Imprisonment of husband/partner;
- (iv) Sudden loss of employment;
- (v) Beneficiaries of Basic Retirement Pension/Widow's Basic Pension/Invalid's Basic Pension/Orphan's Basic Pension, living alone and paying rent;
- (vi) Grant for purchase of medicine to centenarians;
- (vii) Families with twins and above subject to family income not exceeding ceiling as provided for in existing legislations; and
- (viii) Abandoned children.

#### Other types of Social Aid in cash

- Grant to purchase assistive devices (hearing aids, spectacles, wheelchairs and dentures), payable to suppliers upon delivery to beneficiaries;
- (ii) Refund of examination fees to students taking part in vocational training examinations;
- (iii) Allowance to discharged prisoners;
- (iv) Allowance to flood victims and evacuees in Evacuee centres;
- (v) Allowance to fire victims:
- (vi) Allowance to centenarians for the purchase of medicine;
- (vii) Assistance to twins/triplets;
- (viii) Funeral grant;
- (ix) Rent allowance to needy beneficiaries of Basic Retirement Pension/Widow's Basic Pension/Invalid's Basic Pension/Orphan's Basic Pension living alone and paying rent;
- (x) Allowance for purchase of rice and flour;
- (xi) Single Mother's Allowance;
- (xii) Allowance for purchase of dentures which is a one-off payment to beneficiaries of Basic Retirement Pension who would have qualified for Social Aid in absence of Basic Benefit;
- (xiii) Unemployment Hardship Relief to every unemployed person under the age of 60; and
- (xiv) Surviving Partner's Allowance.

#### **WELFARE OF SENIOR CITIZENS**

The Ministry is responsible for the empowerment, protection and promotion of the well-being and welfare of all senior citizens. A senior citizen is defined as someone who has reached the age of 55 or above. A senior citizen is eligible for membership in a Senior Citizen Association affiliated with the Senior Citizens Council. Any senior citizen can participate in the welfare activities organised at the Elderly Day Care Centres. Sensitisation campaigns are equally held to create awareness about the rights of senior citizens.

#### **Welfare and Elderly Persons' Protection Unit (WEPPU)**

The Welfare and Elderly Persons' Protection Unit was set up in September 2006 after the promulgation of the Protection for Elderly Persons Act 2005. The WEPPU also exercises supervision and control over Residential Care Homes.

The main objective of the Act is to provide a legal and administrative framework for greater protection and assistance to elderly persons.

The main functions of the Welfare and Elderly Persons' Protection Unit are to:-

- ensure protection of the elderly;
- (ii) receive complaints from elderly persons who are in need of protection or assistance and to take such measures as may be necessary;
- (iii) organise public awareness campaigns on the rights of elderly persons and the need to provide them with assistance and protection;
- (iv) exercise general supervision and control over Residential Care Homes in line with the Residential Care Homes Act 2003 and Residential Care Homes Regulations 2005;
- (v) ensure that the codes of practice for Residential Care Homes are being observed;
- (vi) participate in the birthday celebration of centenarians:
- (vii) organise leisure activities for residents of Charitable Institutions and senior citizens; and
- (viii) organise programmes for the elderly living alone.

#### Main achievements for the year 2022/2023

- (i) Incontinence Allowance of Rs 1,800 per month has been approved as a budgetary measure and is being paid to Charitable Institutions regarding inmates suffering from Incontinence since July 2022;
- (ii) Opening of Roche Brunes Elderly Day Care Centre on 10th September 2022 and is operational; and
- (iii) Launching of Mobile App for Senior Citizens subject to abuse on 01st October 2022.

#### Elder Abuse

Elder Abuse, whether physical, emotional, financial or in the form of neglect are reported to the WEPPU through two hotlines: 199 which operates on a 24/7 basis and 172 which operates from 09 00 hrs to 16 00 hrs during working days as well as through referrals by Elderly Watch Management Committees (described below); Police; Ministry of Gender Equality and Family Welfare; relatives and neighbours; and the Press. Officers intervene promptly to take actions as appropriate on a case to case basis. Actions include individual and family support, mediation, family conferencing and referrals to Hospitals and Police, amongst others. The Psychologists posted at the Unit provide support to the victims and their families through counselling sessions.

#### New Mode of reporting through mobile application-SEKIRITE

Once an elderly person has downloaded the application on his/her mobile phone, he/she can press on the panic button and alert the nearest police station in case of danger.

#### **Elderly Watch**

Elderly Watch Management Committees were set up under the Protection of Elderly Persons Act 2005 to:

- (i) promote the welfare of elderly persons in the region they are responsible for;
- (ii) prevent acts of abuse on elderly persons; and
- (iii) report cases of abuse against elderly persons, to the Welfare and Elderly Persons Protection Unit.

There are 20 Elderly Watch Management Committees around the island, composed of volunteers and other persons of good repute. They operate at grass root level to promote and protect the welfare of the elderly persons in their respective regions. They identify and report cases of elder abuse to the Ministry via the WEPPU.

#### **Elderly Day Care Centres**

Elderly Day Care Centres organise activities and programmes for the benefits and welfare of the elderly, as follows:-

- (i) Preventive health care;
- (ii) IT literacy to promote lifelong learning; and
- (iii) Leisure, educational and empowerment programmes.

There are at present 22 Elderly Day Care Centres which are listed at **Annex II**.

#### **Recreation Centres**

This Ministry operates four Recreation Centres namely:

These Recreation Centres provide residential, leisure and entertainment facilities for senior citizens and persons with disabilities. Several empowerment activities are organised for the elderly participants, namely, talks on health & nutrition, security and road safety, crime prevention, financial services and sensitisation on the Elderly Protection Act, amongst others. Swimming sessions are organised under the supervision of a Life

Saver. A luxury coach is attached to each Recreation Centre for a local leisure tour for all elderly participants during their residential stays. Each Recreation Centre is also equipped with a medical room attended by professional Nursing Officers hired to provide basic Life Care services. The Recreation Centres also allow for networking among senior citizens.

Security services are provided at each Recreation Centre on a 24/7 basis by professional security service providers. Moreover, each centre avails a network of CCTV camera surveillance system for enhanced security of residents.

At present, some **35,000** elderly and disabled participants are accommodated each year in the three Recreation Centres. The total capacity is expected to reach some **47,000** with the coming into operation of the new Recreation Centre at Riambel.

#### Charitable Institutions

Subsidised residential care homes provide accommodation and support services for individuals who are unable to live independently due to age, disability, or other vulnerabilities. They receive grants from the government to help offset the costs of operation and which also cover staffing, maintenance and other essential expenses. There are 23 such homes in Mauritius. The list of Charitable Institutions is at **Annex IV**.

#### **Foyer Trochetia**

Foyer Trochetia which operates under the aegis of this Ministry in collaboration with Arya Sabha Mauritius, has a capacity to accommodate up to 164 bedridden residents. Age criteria has been reduced to 40 years. The Foyer also accommodates persons suffering from autism who come from broken families.

The Foyer provides the following services:

- (i) a homely environment for residents to enjoy a decent life;
- (ii) medico-social care to elderly persons with severe disabilities by a multidisciplinary team such as Physiotherapists, Occupational Therapists, and trained Nursing Officers; and
- (iii) cremation or burial of residents whose family or kin are abroad or refuse to take charge of them.

#### Residence Bois Savon

Residence Bois Savon, situated at Sainte Croix, Port Louis, provides accommodation to widows over 60 years, living alone, who are eligible for Social Aid and who were previously occupying rented premises.

The complex is maintained by this Ministry. It comprises 24 blocks of which 5 are occupied. Residents only pay for their electricity and phone bills while the CWA charges are settled by this Ministry.

#### **WELFARE OF PERSONS WITH DISABLITIES**

The Ministry empowers persons with disabilities and promotes their inclusion into mainstream society. In addition, all persons having an incapacity of 60% or more, are provided with a Basic Invalidity Pension which amounts to Rs 10,000 monthly and Carer's Allowance of Rs 3,500 is given to those who are severely disabled and need constant care and attention.

#### **Disability Empowerment Unit**

The Disability Empowerment Unit enhances the quality of life of people with disabilities through the provision of enabling opportunities for choice and inclusion into the community through education, training and empowerment and by offering them a means of livelihood.

The following services are provided by the Disability Empowerment Unit:

- (i) refund of equivalent to bus fares to children with disabilities attending schools/day care centres and specialised schools;
- (ii) refund of taxi fares to students with severe mobility problems attending primary schools, colleges and tertiary institutions;
- (iii) monthly stipend of Rs 750 under the François Sockalingum Award to students with disabilities who join secondary education;
- (iv) concessionary airfare;
- (v) concessionary fee for passport;
- (vi) free parking coupons [Yellow parking coupons are issued, on application, to any disabled person to be used in any vehicle in which the disabled person is travelling and on which a passport size photo of the latter should be affixed. Blue parking coupons are issued to be used: (i) in a vehicle driven by a disabled driver; or (ii) by the owner of a vehicle (disabled individual/Association/NGO/Day Care Centre/Specialised school) on whose name the horse power of the vehicle is registered];
- (vii) Respite Care Programme;
- (viii) facilitating processing of loan for people with disabilities at the Employees Welfare Fund; and
- (ix) duty free facilities to persons with disabilities.

#### **MEDICAL UNIT**

The Medical Unit provides the following services:

- (i) free monthly domiciliary medical visits to:
  - a) severely disabled or bedridden persons aged 0 89 yrs in receipt of Carer's Allowance; and
  - b) elderly persons aged 90 and above.
- (ii) annual anti-influenza vaccination campaigns for the elderly and severely disabled children;
- (iii) medical and paramedical care to the inmates of Charitable Institutions; and
- (iv) preventive health care.

#### **Medical Tribunal**

The Medical Tribunal hears appeal from claimants who are not satisfied with the decision of the Medical Board regarding their claims for:

- (i) Invalid's Basic Pension;
- (ii) Additional Invalid's Basic Pension (Carer's Allowance);
- (iii) Carer's Allowance for severly disabled elderly person; and
- (iv) Disablement Pension (aged 15 and over) following injury at work (as per Section 26 of National Pensions Act)

The Medical Tribunal consists, as per Section 36 of the National Pensions Act, of one Chairperson (with the appropriate legal background) and 2 specialist doctors (in the field of the disease/disability being assessed).

The Medical Tribunal is heard at Astor Court, Port Louis and at Social Security House, Rose Hill. It is serviced by a pool of 6 Chairpersons, 51 Specialist doctors (in the field of cardiology, psychiatry, orthopaedic among others), and 3 Secretaries.

#### PARASTATAL BODIES UNDER THE AEGIS OF THE MINISTRY

There are two Parastatal Bodies operating under the aegis of the Ministry:

#### Training and Employment of Disabled Persons Board (TEDPB)

The Training and Employment of Disabled Persons Board was set up in April 1996 and works towards the integration of persons with disabilities into mainstream employment. The TEDP Act 1996 (amended in 2012) provides that the workforce of all enterprises employing 35 or more employees, should include 3% persons with disabilities. The TEDPB acts as a facilitator in finding employment or training for persons with disabilities. Its main objectives are to:

- (i) prevent discrimination against persons with disabilities;
- (ii) liaise with appropriate vocational and other training institutions for the training of persons with disabilities:
- (iii) educate and sensitise employers on the importance of employing persons with disabilities and contribute to remove barriers or prejudices with regard to the employment of such persons;
- (iv) operate and encourage schemes and projects for the training and employment of persons with disabilities; and
- (v) improve generally the social and economic status and conditions of persons with disabilities.

#### **National Solidarity Fund (NSF)**

The National Solidarity Fund was set up under the National Solidarity Fund Act 1991 with the following objectives:-

- (i) to provide financial assistance to citizens of Mauritius, residing in Mauritius who may require surgical operations which can be performed abroad or in medical institutions in Mauritius, as approved by the Ministry of Health and Wellness; and
- (ii) to provide, with the approval of the Minister, financial assistance directly to individuals who have undergone severe personal hardship.

#### STATUTORY BODIES UNDER THE AEGIS OF THE MINISTRY

There are five statutory bodies operating under the aegis of the Ministry to provide the necessary framework and back up to enable the latter to fulfil its mandate:

#### Lois Lagesse Trust Fund (LLTF)

The Lois Lagesse Trust Fund was set up under the Lois Lagesse Trust Fund Act 1983 to integrate visually impaired persons into mainstream society. Its main objectives are to:-

- (i) aid, train and educate blind and visually impaired persons:
- (ii) assist blind persons in obtaining medical treatment and suitable employment;
- (iii) set up and manage training centres, schools and hostels for the blind;
- (iv) cater for the general welfare of the blind; and
- (v) organise and participate in leisure, recreational, extracurricular activities including music and sports.

#### National Council for the Rehabilitation of Disabled Persons (NCRD)

The NCRD is a corporate body which was set up under the National Council for the Rehabilitation of Disabled Persons Act 1986 as the National Coordination Committee on disability issues. Its main objectives are to:-

- (i) promote the welfare of persons with disabilities:
- (ii) co-ordinate the activities of voluntary organisations catering for disabled persons;
- (iii) promote the development and expansion of rehabilitation services;
- (iv) advise on aspects of disabled persons; and
- (v) co-ordinate with private national and international agencies engaged in the rehabilitation of disabled persons and to disseminate technical information received from these sources.

#### **Residential Care Homes Board (RCHB)**

The Residential Care Homes Board was set up under the Residential Care Homes Act 2003, proclaimed with effect from 21 August 2004 and has as main objectives to:

- (i) exercise general supervision and control over residential care homes;
- (ii) establish codes of practice for residential care homes and monitor compliance with the codes;
- (iii) effect inspection visits at residential care homes to ensure compliance with existing legislations;
- (iv) process applications for residential care home licences including renewal.

A list of residential care homes (Charitable and Private) as at 30 June 2023 is at **Annex IV and Annex V** respectively.

## Senior Citizens Council (SCC)

The Senior Citizens Council is a body corporate governed by the Senior Citizens Council Act 1995 (amended in 2011) and operates under the aegis of the Ministry.

Its main objectives are to:

- (i) promote activities and projects for the welfare of senior citizens;
- (ii) maintain effective communication with senior citizens;
- (iii) establish contacts with organisations engaged in similar activities in Mauritius and abroad;
- (iv) advise the Government on matters relating to the welfare of senior citizens; and
- implement such policies and programmes in favour of senior citizens, as may be specified or approved by the Minister.

# **About Our People**

For the period under review, the Ministry was manned with a workforce of 836 persons coming from the technical and administrative cadre. They were deployed under different Departments/Units.

The total amount disbursed to meet the costs of training in financial year 2022-2023 was Rs 2,202,146.25.

# **PART II – Achievements of the Ministry**

## Main Achievements for Financial Year 2022-2023

The social protection programmes have always focused on the welfare of the poor, the vulnerable, the disabled and the elderly.

#### 1. Timely payment of pensions

As it has been the practice since several years now, the Ministry has ensured timely payment of all benefits (pensions) to every eligible beneficiary in spite of the fact that the total number of beneficiaries decreased by 0.41% from July 2022 to June 2023. There were 314,047 beneficiaries of basic benefits for the year under report and this represents a net decrease of about 1,307 cases as compared to 315,354 in financial year 2021-2022. A total of 49,442 new claims for benefits were registered, out of which 19,619 were claims for Basic Retirement Pension. The total outlay on benefits for the financial year was Rs 43,457,753,041. This represents an increase of 15.99% over the previous financial year where total payments reached Rs 36,507,685,721. A breakdown of the basic benefits is given in Table 8.

#### 2. Control on overpayment of benefits

The Ministry pursued a policy of zero tolerance with regard to payment of benefits to those who do not satisfy the conditions prescribed in the National Pensions Act 1976 and its concomitant Regulations. The National Pensions Officers detected 583 cases where benefits should not have been paid, amounting to Rs Rs 79,719,285.50. Consequently, 355 cases were solved and settled, and an amount of Rs 38,201,247.15 were recovered.

Information on deaths and remarriages were communicated to the Ministry through the Info-Highway platform on the very next day they were reported at the Civil Status Division.

The Passport and Immigration Office is also connected to the Info-Highway platform and information on travel movements of all beneficiaries (of Basic Retirement Pension, Widow's Basic Pension, Invalid's Basic Pension, Widower's Pension, and Child's Allowance) is obtained on a daily basis. Payment of benefits are automatically suspended for those who have left the country for more than six months. Same are released when they turn up.

The Monitoring Committee, chaired by the Permanent Secretary, meets at least once a month to take stock of the status of detection and recovery of overpaid benefits.

#### 3. Payment of Widower's Contributory Pension

The National Pensions Act was amended in July 2016 to introduce the Widower's Contributory Pension thereby eliminating gender discrimination in payment of Widower's Contributory Pension. Where a female spouse contributing to the National Pensions Scheme dies, the surviving partner (the widower) is now entitled to a Widower's Contributory Pension on the same condition as a Widow's Contributory Pension. 1,838 persons benefitted from this scheme for the period July 2022 to June 2023.

#### 4. Payment of National Savings Fund lump sum at the age of 60

The National Savings Fund Act was amended in July 2016 to enable payment of lump sum from contribution at age of 60 to contributors of the Fund who retire before or stop being in employment before the age of 60. A total of 21,627 applications were processed and an amount of Rs 1,333,319,571.29 was paid. Details are given below:

#### 5. Funeral grant, dentures, flood victim and fire victim allowances

A multitude of allowances were delivered in respect of funeral grant, dentures, flood victims and fire victims. The number of beneficiaries were as follows:

- funeral grant (3860 cases)
- flood victims (393 cases)
- dentures (1021 cases)
- fire victims (138 cases)

#### 6. Provision of Assistive devices

13,403 spectacles, 1,302 wheelchairs and 619 hearing aids were provided to eligible beneficiaries.

## 7. Social Register of Mauritius

#### Housing Scheme (Mauritius)

Under this scheme, 172 applications were processed and 101 applications were found eligible.

#### Housing Scheme (Rodrigues)

Nil applications were processed for the Rodrigues Regional Assembly.

#### • Scholarship Scheme

The Scholarship Scheme for vulnerable families was introduced by the Ministry of Education and Human Resources in 2014. The income threshold is Rs 10,500. 6 applications were processed and 4 applications were found eligible.

#### • New MSI-SRM Subsistence Allowance Scheme

5,497 applications were processed for the Social Integration Division and 3,987 applications were found eligible.

#### 8. Disability Sector

#### Payment of Invalid's Basic Pension to children with disabilities

- (i) The National Pensions Act was amended in July 2016 to remove age discrimination in payment of Invalid's Basic Pension to children with disabilities. Consequently, 3,195 children with disabilities below 15 years who prior to this amendment were deprived of the Invalid's Basic Pension of Rs 9,000, were paid for the period July 2022 to June 2023.
- (ii) A Carer's Allowance of Rs 3,500 is also paid in case the child needs constant care and attention as certified by the Ministry's Medical Board. Accordingly, 1,121 children were covered.

### Refund of travelling expenses (equivalent to bus fare) to children with disabilities

1,962 children with disabilities were refunded their travelling expenses amounting to Rs 19,650,970 to attend specialised schools/Day Care Centres.

#### Refund of taxi fares to students with disabilities

36 children with disabilities were refunded their taxi expenses, amounting to Rs 1,969,085 to attend primary, secondary and tertiary institutions.

### Parking Coupons to persons with disabilities

408 persons with disabilities were provided with parking coupons during the period July 2022 to June 2023 as follows:-

#### National Council for the Rehabilitation of Disabled Persons

Under the **François Sockalingum Award**, 62 secondary school students with disabilities were offered a monthly stipend of Rs 750 amounting to a total of Rs 627,250 for the year 2022-2023.

### Training and Employment of Disabled Persons Board (TEDPB)

(i) 60 persons with disabilities were trained and 32 were employed for the period July 2022 to June 2023. Details are given below:

### (ii) Assessment Committee for persons with disabilities

The Employment Section at the TEDPB has organised 11 (eleven) Assessment Committees, respectively on 05 August 2022, 16 August 2022, 26 August 2022, 08 September 2022, 16 September 2022, 19 September 2022, 20 September 2022, 10 November 2022, 01 March 2023, 16 March 2023 and 15 June 2023 for 69 persons with disabilities who were assessed for Training and Employment; to be able to register with TEDPB.

### (iii) Update of register of persons with disabilities

The TEDPB started an updating exercise for records of persons with disabilities registered with the Board. Letters were sent requesting persons with disabilities to liase with the TEDPB in order to update their records. As at 30 June 2023, the register showed a record of 476 persons with disabilities who were actively looking for training and/or employment.

### Vaccination against Influenza

Every year prior to the coming of the cold seasons, the Medical Unit carries out an Anti-Influenza Vaccination programme for the elderly above 60 years, residents of Charitable Institutions and Private Residential Care Homes and persons with severe disabilities (including children) in order to protect the latter against influenza related health complications.

The Anti-Influenza vaccination campaign was held from 05 April 2023 to 27 July 2023.

The vaccination campaign was carried out all over the island in Village Halls, Municipal Halls, Community Centres and Social Welfare Centres according to an established calendar which was widely circulated to the public. Bedridden or severely disabled persons in receipt of Carer's Allowance who were unable to attend vaccination centres, were vaccinated at their domicile by their Visiting Medical Doctors.

As at 04 August 2023, a total of 54,892 vaccines were utlised, including 3,000 doses sent to Rodrigues and 15 doses sent to Agalega.

The Ministry procured 55,500 vacccines. 2,464 have been administered in Charitable Institutions/Private Homes. 1,120 vaccines have been administered to disabled persons attending Specialised Schools. 23,904 vaccines have been effected to bedridden or serverely patients at their domicile. 24,389 vaccines have been used to vaccinate Elderly in vaccination centres.

### Services of Physiotherapists and Occupational Therapists

Physiotherapists and Occupational Therapists provide services on sessional basis in Charitable Institutions and Foyer Trochetia. Physiotherapists also effect visits to children with muscular dystrophy disease and provide a 'Service de Proximité' to elderly persons with disabilities and those living alone. This service started in June 2016 for elderly persons aged 90 years old and above including centenarians in receipt of Carer's Allowance in order to improve their quality of life.

A total of 111 bedridden and severely disabled elderly above 90 years old who were eligible for Carer's Allowance on a permanent basis, benefitted from the services of the Physiotherapists and Occupational Therapists.

111 elderly persons were visited by Physiotherapists (333 sessions) and Nil elderly persons were visited by Occupational Therapists (0 sessions).

#### **Physiotherapists**

- (i) No. of sessions for Muscular Dystrophy for Children was 518
- (ii) No. of sessions carried out at Charitable Institutions was 1,484
- (iii) No. of sessions carried out at Foyer Trochetia was 142

### **Occupational Therapists**

- (i) No. of sessions carried out at Charitable Institutions was 1,107
- (ii) No. of sessions carried out at Foyer Trochetia was 263
- 317 Doctors provided services on sessional basis in Charitable Institutions, Foyer Trochetia, and on Medical Boards and also conducted domiciliary visits.

 Medical and Paramedical Care were provided to the 22 registered Charitable Institutions operating in Mauritius.

### National Pensions Appeal Tribunal (NPAT)

The NPAT was set up under Section 36 of the National Pensions Act 1976. The Tribunal consists of a Chairperson who is a legally qualified person appointed by the Attorney-General and two other members appointed by the Hon. Minister of Social Integration, Social Security and National Solidarity after consultation with the Employer and Employee representatives, respectively.

The NPAT considers appeals from claimants for benefits against decisions of the National Pensions Officer or of the Minister in accordance with the regulations of the National Pensions Act and regulations made thereunder.

346 cases were scheduled for the period July 2022 to June 2023 at the NPAT out of which 246 were set aside, 42 were allowed and 54 were reconvened.

#### Service de Proximité

The Ministry started this service in June 2016. For the period July 2022 to June 2023, some 111 cases were visited by the Physiotherapists (333 Sessions) and Nil cases were visited by the Occupational Therapists (0 Sessions).

#### Medical Boards

The Medical Unit prepares and schedules Medical Board sessions for new applications and renewal of cases. 33, 935 claimants were scheduled for period July 2022 to June 2023.

- (i) Beneficiaries of Invalid's Basic Pension or Carer's Allowance
  For the period July 2022 to June 2023, 18,720 claimants were examined out of which
  10,602 cases were allowed and 8,118 claimants were not recommended for Invalid's
  Basic Pensions or Carer's Allowance.
- (ii) Persons aged 60 years old benefiting from Basic Retirement Pension/Severely Handicapped and who need the constant personal attendance of another person for their daily activities

4,976 Claimants were examined out of which 2,880 cases of the Basic Retirement Pension were allowed and 2,096 cases were disallowed for the period July 2022 to June 2023.

Medical assessment for cases referred to the Medical Board is conducted in the following ways:

- (i) claimants scheduled before the Medical board (around 2,900 cases assessed monthly); and
- (ii) if the claimant is bedridden, the medical assessment is done at his/her residence, through a domiciliary visit (average of 1,700 cases monthly).

### (i) Domiciliary Visits Medical Examination (DV)

Claimants suffering from any disablement and who are bedridden can apply for: either Invalid's Basic Pension, Carer's Allowance or Basic Retirement Pension for severly disabled elderly, through their proxy. Then, a domiciliary visit is scheduled and a General Practitioner (from the Ministry) visits and examines these persons at their place of residence in order to assess their disablement and make recommendations for pension purposes.

20,166 claimants were scheduled for period July 2022 to June 2023.

An average of 26,063 persons comprising bedridden or severely disabled elderly aged 0-89 yrs and elderly persons aged 90 and above benefitted from monthly Domiciliary Visits.

A total of 312,754 Domiciliary Visits were carried out on bedridden persons aged 0-89 years (270,173 visits) and elderly persons aged 90 years and above (42,581 visits).

2,908 cases of Invalid's Basic Pension and 9,406 cases of BRP/SH were allowed for Domiciliary Visits during the period July 2022 to June 2023.

#### Social Aid Boards

In addition, General Practitioners also service medical sessions to examine claimants applying for Social Aid on medical ground. Social Aid sessions are held at Social Security Offices, Area Health Centres and Hospitals. 753 Social Aid Boards were scheduled for the period of July 2022 to June 2023.

### Injury Boards

Medical Injury Boards Sessions are also scheduled to examine persons contributing to the Social Contribution and Social Benefits Scheme, and who are injured at work or are suffering from any prescribed occupational diseases, as mentioned in the Social Contribution and Social Benefits Act, with a view to determining the percentage of loss or faculty/incapacity. 275 cases were examined during the period July 2022 to June 2023, out of which 230 cases were allowed.

#### Medical Tribunal

Out of 5,521 applications, 5,327 appeal cases were examined before the Medical Tribunal for the period July 2022 to June 2023. Consequently, 1,774 cases were allowed and 3,553 cases were disallowed.

### 10. Cases of Elder Abuse reported to the Welfare and Elderly Persons' Protection Unit

Overall, a total number of 1,168 elder abuse cases was reported for the period July 2022 to June 2023 through the Ministry's hotlines – 199 and 172 as well as referrals by Elderly Watch Management Committees; Police; Ministry of Gender Equality and Family Welfare; relatives and neighbours; and the Press. All cases were resolved as at June 2023.

### 11. Senior Citizens Council (SCC)

### 1. Workshop/Brainstorming Session

A workshop was held on Thursday 10 July 2022 in the Training Unit of the Ministry of Social Integration, Social Security and National Solidarity. Proposals for amendments to the Senior Citizens Council Act were made with a view to making the Act more responsive to the needs of the elderly persons in the light of new emerging issues.

#### 2. Annual General Meeting

The Annual General Meeting of the Senior Citizens Council was held on 20 July 2022. at the Tamil League Hall, Réduit at 10 30 hours. The Financial Statements for years 2019/2020 & 2020/2021 were presented and adopted after the President's report.

### 3. Election of District Representatives

The Election of 10 district representatives was held on Saturday 10 September 2022. The Electoral Commissioner's Office conducted the abovenamed election.

### 4. Digital Literacy

Digital Literacy Courses in collaboration with the National Computer Board were organised from October to December 2022 as follows:

### 5. Talks by National Human Rights Commission

Talks by officers of the Human Rights Commission was held at the Gorah Issac Municipal Centre on 21 October and at Roches Brunes Elderly Day Care Centre on 25 October. Some 60 seniors from both regions attended same.

#### 6. Annual Grant to Senior Citizen Associations

Mauritius: The launching ceremony was held on Wednesday 16 November 2022 in the Conference Room of the Social Security House in Rose Hill in the presence of the Hon Minister Mrs Fazila Jeewa-Daureeawoo, GCSK where Presidents/Representatives of Senior Citizens Associations of Lower Plaines Wilhems (Beau Bassin, Rose Hill and Quatre Bornes) were handed over their annual grant in form of cheques.

The Hon Minister also attended the distribution on 24 November 2022 at the Gorah Issac Municipal Hall, Port Louis in the presence of some 69 Senior Citizens Associations.

The distribution of the annual grant in other districts was held from 16 to 30 November 2022.

Rodrigues: In the course of a visit to Rodrigues, a function in the presence of the Hon Minister Mrs Fazila Jeewa-Daureeawoo, GCSK was organized by the SCC on 25 September 2022 to distribute the 2021 Annual Grant.

The annual grant handing over ceremony for year 2022 was held on 07 December 2022 at Centre Manique, La Ferme, Rodrigues. Forty-eight eligible Senior Citizens Associations were handed over their annual grant by the Chairperson of the Senior Citizens Council and Mr M. Samoisy, President of the Rodrigues Federation of Senior Citizen Associations and other dignitaries.

### 7. World Remembrance Day for Road Traffic Victims

An activity consisting of video clips, drama, song and "Temoignage" was held on Monday 21 November 2022 at the Salle des Fêtes, Plaza, Rose Hill in the presence of Honourable Mr Alan Gannoo, Minister of Land Transport and Light Rail, and Hon Mrs Fazila Jeewa-Daureeawoo, GCSK Minister of Social Integration, Social Security and National Solidarity. Some 400 seniors attended the function.

### 8. Human Rights Day

An awareness session on human rights of senior citizens was held on Tuesday 13 December 2022 at 10 30 hours at the Saint Pierre Elderly Day Care Centre. Some 45 seniors and 13 Elderly Welfare Assistants attended the session. The speaker was

Mr D.B. Seetulsing, S.C, G.C.S.K and Chairperson of the National Human Rights Commission.

### 9. Handing over of certificates icw Training of Staff

A function was held on 20 December 2022 at the St Pierre Elderly Day Care Centre to hand over certificates to the Staff of the Council who had followed training sessions organised by the Ministry of Social Integration, Social Security and National Solidarity. The objective of the abovenamed training would give employees a better understanding of their responsibilities and the knowledge and skills needed to do their job.

### 10. Quiz Competition

In line with the programme of activities, a Quiz competition was organised on regional basis from March to June 2023. 584 participants from 166 Senior Citizens Associations participated in the competition. Winners at district level would participate at National level.

#### 11. Games Tournament

Games Tournament in Carrom, Domino, Draught and Petanque have been carried out district wise from April to June 2023. 995 Participants from 499 Senior Citizens Associations took part in games tournaments.

### 12. Drama Competition

Preliminaries started on 25 May 2023 in the categories Bhojpuri and Creole following a training session by Officers of the Ministry of Arts and Cultural Heritage on 3 May 2023. 21 groups both in Creole and Bhojpuri with a total number of 133 participants showcased their talents in the drama competition. The finals comprising

4 groups in Creole and 3 in Bhojpuri were held on 05 July 2023 at the MGI Auditorium in the presence of 900 seniors.

### 13. Annual General Meeting

AGM was held on 7 June 2023 at the Tamil League in the presence of some 500 Members of Senior Citizens Associations.

### 14. International Day for Older Persons

In joint collaboration with this Ministry, a function was organised in the context of the International Day for Older Persons on 1 October 2022 at Trianon Convention Centre. The honourable Prime Minister launched the mobile application SEKIRITE on that day.

### 15. Other Activities - Centenarian's Birthday Celebrations

The Chairperson and District Representatives have attended all the 100th birthday celebrations of centenarians during the year 2022 to date. Moral support and gifts are given to centenarians at the functions. Birthday celebrations were held for 68 (9 males and 59 females) centenarians with provision of various gifts.

### 12. National Solidarity Fund

3,245 applications were received at the NSF in financial year 2022-2023. An amount of Rs 59,393,002 was disbursed in favour of 3,132 beneficiaries (also comprising cases for the previous year). Details are given below:

The portal enables citizens to register their complaints online through a unique reference number on a 24/7 basis. Out of 876 tickets assigned to this Ministry in the period under report, 875 complaints were resolved as at 30 June 2023.

### **Audit Committee for Year 2022-2023**

The Audit Committee at this Ministry, constituted in September 2022, has as main objective to ensure that the recommendations made in the Director of Audit Report 2021-2022, Internal Control Reports for financial year 2021-2022, Office Of Public Sector Governance Report on Overpayment and Corruption Risk Assessment, are implemented. As at 30 June 2023, 02 meetings of the Audit Committee were conducted.

### **PART III – Financial Performance**

### **Financial Highlights**

A budget of **Rs 46,425,000,000** was allocated to the Ministry in financial year 2022-2023, which was **20.3**% more than last year's budget. The budget is classified under the following sub-heads:

Recurrent Expenditure 111,600,000

Sub-Head 09-202 : Social Protection

Recurrent Expenditure 1,607,700,000

Capital Expenditure 70,000,000

Sub-Head 09-203 : National Pension Management

Recurrent Expenditure 44,635,700,000

TOTAL 46,425,000,000

The budget of the Ministry represents some 30.54% of the total appropriation of Government Expenditure for financial year 2022-2023.

Expenditure caters mainly for payment of Basic Pensions and Social Aid to the senior citizens, vulnerable groups and disabled persons.

The voted provision for payment of social benefits represents some 97.9% of the total vote for the Ministry.

The two types of revenue collected by the Ministry, described under vote item 'Revenue from Property Income, User Fees and Other Sources and Sale of Goods and services' are:

- Benefits recovered: Rs 57,766,769
- Reimbursement of cost of NPF Administration: Rs 76,209,138

### **Analysis of Major Changes**

An analysis of Revenue and Expenditure over the past five years was carried out. Figures for financial years 2018-2019, 2019-2020, 2020-2021, 2021-2022 and 2022-2023 were taken for comparative purposes.

### Revenue

The revenue collected by the Ministry for the last five fiscal years in respect of the two revenue items: Benefits recovered; and Reimbursement of cost of NPF Administration is given in the chart below.

Revenue collected under item - Benefits recovered, increased by 9.49% from Rs 52,757,571 in 2021-2022 to Rs 57,766,769 in 2022-2023 while revenue collected under item - Reimbursement of cost of NPF Administration showed a decrease of 0.02% from Rs 76,224,640 in 2021-2022 to Rs 76,209,138 in 2022-2023.




Figure 3: Breakdown of Revenue collected by Ministry

### **Expenditure**




Figure 4: Actual Expenditure for financial years 2018-19 to 2022-23

The actual amount spent under the different expenditure categories for the last five fiscal years are shown in Figure 4 below:

Figure 4 demonstrates that payment of Social Benefits is still the core expenditure category of the Ministry's budget. Payment of Social Benefits has been increasing over the years and is mainly due to the rising number of beneficiaries of basic pensions. Consequently, the payment of basic pensions for financial year 2022-2023 had grown up to Rs 43,457,753,041.

#### Capital Expenditure

The construction of the Ministry's fourth Recreation Centre at Riambel was completed in June 2021. Retention money of 10% was to be paid in financial Year 2021-2022 but was however delayed due to some unfinished works. Funiture and equipment required have already been purchased for an amount of Rs 1,474,800 The contract (project value: Rs 215,300,000) was awarded to Beijing Zhuzong Group Co Ltd in June 2016. The project was monitored by a technical team from the Ministry of National Infrastructure and Community Development.

Other minor projects undertaken during the financial year include:

- (i) Upgrading of Recreation Centres;
- (ii) Upgrading of Disability Centre Refurbishment and Upgrading Works;
- (iii) Upgrading of Residence Bois Savon;
- (iv) Upgrading of Social Social Security Offices; and
- (v) Acquisition of IT Equipment.

The expenditure on the ongoing Capital projects undertaken by the Ministry for the year 2022-2023 are shown in the table below:

### **Payment of Non Contributory Pensions**

The budget for Basic Pensions increased considerably from Rs 36,750,000,000 in financial year 2021-2022 to Rs 44,340,000,000 in 2022-2023, mainly due to the increase in the number of beneficiaries. The actual expenditure under Basic Pensions as at 30 June 2023 was Rs 43,457,753,041. The table below shows the payment made under the different types of Basic Pensions and the corresponding number of beneficiaries:




Figure 5: Payment of Basic Pensions

### **Payment of Social Aid**

There are different types of Social Aid that are paid. These payments are effected under the Social Aid Act, Unemployment Hardship Relief Act and National Pensions Act. The budgeted provision in respect of Social Aid for financial Year 2022-2023 was Rs 972,000,000, of which a total amount of Rs 856,056,967 was spent.

The chart below describes the percentage of expenditure of the different types of payments effected under Social Aid.

#### Social Aid in cash

Major disbursements effected in respect of Social Aid in cash in financial year 2022-2023 are given below:

- (i) 291.5 Million paid as Social Aid;
- (ii) 263.4 Million paid as Income Support for rice and flour; and
- (iii) 123.7 Million transferred to the Ministry of Blue Economy, Marine Resources, Fishries and Shipping for payment of Bad Weather and Closed Season Allowances to fishermen.




Figure 6: Payment of Social Aid in Cash

### **Grant for purchase of Assistive devices**

The grant payable in respect of Assistive devices, is as follows: Wheelchair – Rs 10,000

Hearing Aid – Rs 10,000 per ear

Spectacles – Rs 5,000 Dentures – Rs 4,222




Figure 7: Grant for purchase of Assistive devices

Out of an approved provision of Rs 60,000,000 (+Rs 26,900,000 from Reallocation), an amount of Rs 86,616,698 was disbursed for purchase of assistive devices in financial year 2022-2023. A breakdown of the expenditure is shown in Figure 7 below:

### **PART IV – Challenges**

### **Elderly Sector**

### Impact of Ageing on Pension

The phenomenon of an ageing population will have a direct impact on our social protection system. It is expected that the pensioner support ratio will go down to 3:1 in 2030 compared to 6:1 as at now. The number of Basic Retirement Pension beneficiaries has reached 261,269 as at June 2023 and it is expected to rise to 343,000 by 2054. With a decreasing birth rate, an increasing life expectancy and an increase in the number of old people aged 60 and above, the sustainability of the pension system represents a real challenge.

### Increasing demand for Elderly Day Care facilities, Charitable Institutions and Private Residential Care Homes

With the rise in the nuclear family set up following the new life trends whereby both husband and wife are engaged in their professional activities outside the home, the elderly more often than not will be crowded out of the family circle. There will be a growing demand for quality Elderly Day Care facilities, Charitable Institutions and Private Residential Care Homes. With the growing number of literate and professional retirees, the expectations in terms of quality and types of services at the aforesaid institutions will also need to be addressed. A competitive pressure in terms of demand and supply will become inevitable.

### Protection of the elderly population

Security and protection of the elderly population, be it physical or otherwise, has become a matter of concern. The older generation should be given the necessary framework so that they can continue to live an active and happy ageing while feeling secure and safe in their daily environment. Linked to this is the element of welfare and well-being of the senior citizens. Changing the attitude of health and social service providers is vital to ensure that their practices empower and enable the elderly to remain autonomous as long as possible. A happy old age pensioner is one who is above all safe and secure.

### **Disability Sector**

Mauritius is party to a number of international conventions and treaties on Disability including the United Nations Convention on the Rights of Persons with Disabilities (UNCRPD). The main challenge is to ensure that persons with disabilities are made to join the mainstream of our society. Persons with disabilities should be given due recognition and equal right in accessing public facilities. In view thereof, dedicated professionals should be engaged in this sector and the environment should also be re-engineered to make it more disabled friendly.

The promotion of the rights of persons with disabilities and the protection of persons with disabilities against abuse, violence and neglect should continue in a more sustainable and focused manner. Negative attitude and mindset towards persons with disabilities should be eradicated so that the latter do not find themselves marginalised or held down by their disabilities. Public and private sector employers should be encouraged through appropriate incentives to employ people with disabilities given that demand for lift facilities, ramps hand rails, transport facilities to and from office will increase.
